The candidate- (i) should be a citizen of India; (ii) should have passed 10+2 examination with eligibility as per the Affiliating University a dmission Policy and obtained non zero positive score in Common University Entrance Test (CUET) Under Graduate (UG) or obtained non zero score in CET conducted by the Competent Authority: Provided that, preference shall be given to the candidate obtained non zero positive score in (CUET) Under Graduate (UG) over the candidates obtained non zero score MAH-BCA/BBA/BMS/BBM CET-2025 conducted by the Competent Authority	(i) The candidate should have passed 10+2 examination with eligibility as per the Admission Policy of the Affiliating University; and (ii) Any other eligibility criteria and requirement declared from time to time by the appropriate authority as defined under the Act.

Students who are allocated Bhavans College in their first cap round shall visit Bhavan's College, Pallanji Sadan Bldg ground floor and complete the following steps to confirm their admission

1. Physical verification of documents

- Candidates who have accepted the seat must report to allotted institute for confirmation of admission
- The Institute shall verify the required documents and upload the admission of the candidates in the online system through Institute Login immediately and shall issue a system generated receipt of confirmation of admission and fee paid receipt to the candidate. If it is found that seat allotted to the candidate is on the false claims made in the applications by the candidate, then institute shall not admit such a candidate and such candidate shall raise the grievance by his/her login.
- Students will bring the following documents in **original and 2 attested photocopies** for verification
 - Original and copy of SSC and HSC marksheet (self-attested)
 - Original CET results score card

- XII Std Leaving certificate
- Date of Birth Proof, Aadhar card ,
- Caste certificate, Caste validity certificate from state of Maharashtra only
- Gap Certificate for students who have cleared their 12th Std before 2025
- For Children with more than 40% Physical handicap- Certificate from a government hospital
- Learning Disability (more than 40%)- Certificate from a government hospital
- Students applying in the quota of reservation for open EWS, SEBC/Maratha section (wherever valid as per Govt circulars) should submit valid certificate for the same
- Scanned copy of photos and signature in a pen drive
- Candidates Abc id
- Non creamy layer certificate or income certificate (if applicable)
- Orphan certificate (wherever applicable)
- Undertaking (As per Annexure 1)

2. Online Verification and confirmation of their seat in Bhavans college through CET portal (self freeze if not done already)

a) The candidate shall self-verify the seat allotment made to him/her in the CAP Round I by accepting declaration through his/her login and certifying that his/her claim related with qualifying marks, category, gender, reservation, specific reservation etc. made by candidate in the application form are correct and relevant documents uploaded to substantiate his/her claims are authentic and correct.

3. Freeze admission through payment of admission confirmation fees using student login (if not done already)

a) Candidates who have been allotted the seat **as per their first preference** in Round I (auto frozen) shall pay the seat acceptance fee by online mode through their login and Such candidates shall not be eligible for participation in subsequent Rounds.

b) Candidates who have allotted **other than first preference** and self-freeze their allotment in Round I through their login must accept the seat and shall pay seat acceptance fees through online mode. Such candidates shall not be eligible for participation in subsequent Rounds.

c) Candidates who have allotted **other than first preference and want betterment in the subsequent rounds** must claim the allotted seat in Round I by accepting that seat by choosing Not Freeze option for betterment and shall pay the seat acceptance fee through their login by online mode

- Open the registration link ""cimsstudent.mastersofterp.in""
 - o Click on "Get your user id and password", enter your mobile number. You will very shortly receive a SMS on your mobile number giving your user id and password . Kindly save the details and on a future date change your password
- To start your preadmission registration Sign in on the registration link "cimsstudent.mastersofterp.in""
- The dashboard of the service provider Mastersoft opens up
- At the sidebar go to "Online registration" and see that all the tabs within it are filled wrt to
 - o Personal details (Student Name is Non editable)
 - o Address Permanent and current
 - o Upload Photo
 - o Upload signature
 - o Exam details as asked
 - o Go to" Subject preference and tick your optional groups only
- Tick I agree to terms or confirm the data
- Pay your on-line charges for registration, (Rs 220) using either debit card, paytm etc (NOTE: NO OFFLINE/cash REGISTRATION CHARGES WILL BE ACCEPTED)
- Print your receipt and registration form and **TAKE PARENTS SIGNATURE ON IT**
- Print the attendance Undertaking form, e insurance form, anti ragging undertaking from bhavans college website and manually sign it AFTER READING IT.
